I. General description and use

The board is designed for a race walking event. According to the IAAF Competitions Rules 2016-2017 (Rule 230 (e)) it is used to keep competitors informed about numbers of red cards and types of offences: loss of contact with ground or bent knee. The board contains up to 30 bib numbers (four digits) in two columns with four offences for each row.

IV. Operation and maintenance

If there are 30 competitors or less in the race, officials put all of the bib numbers on the board using magnetic digits before the race. If the number of the competitors exceeds the board capacity, the bib numbers and the offence marks are put on the board as the red cards arrive during the competition. The board is designed for magnetic digits and magnetic marks only. Do not use any markers, they will damage the surface. The product should be stored in a dry roofed place.


V. Packing and transport
